

# An example session for analyzing quantitative MRI data in the Multi-Parameter Mapping framework

This document illustrates the workflow of analyzing quantitative Magnetic Resonance Imaging (qMRI) data in the framework of Multi-Parameter Mapping (MPM) experiments (Weiskopf et al. 2013). The example uses artificial noisy MPM data based on the analysis results of a publicly available MPM dataset, see <https://hmri.info>: The original data was modeled using the ESTATICS model (Weiskopf et al. 2014). Its four adaptively smoothed parameter maps were used to generate the artificial data on a selected (small) sub cube with Rician noise by creating corresponding signal echos following the ESTATICS model equation. The artificial data is supplied with this package together with the smoothed quantitative maps (relaxation rates  $R_1$  and  $R_2^*$ , proton density  $PD$ , and magnetization transfer  $MT$ ) from the original data for ground truth comparison.

Specifically, the data consist of, in total, 22 image volumes in NIfTI format that correspond to multiple echos of three different imaging modalities, i.e., 8 echos of  $T_1$  weighted images, 8 echos of proton density ( $PD$ ) weighted images and 6 images from a dual excitation FLASH magnetization transfer ( $MT$ ) weighted sequence. Each echo in the image volumes is “acquired” at an echo time, repetition time and flip angle, that equal those of the original experiment. The quantitative maps suffer from a  $B_1$  transmit (and receive) bias, that can be corrected for, if the smooth  $B_1$  correction field that affects the local flip angle is known (Tabelow et al. 2019). An estimate for this field is supplied with the package, too.

For a more extended introduction we refer to Polzehl and Tabelow 2019 Chapter 6.

## 1 Reading the MPM data

First, we specify the directory where the data are stored within the package

The filenames of the data correspond to the weighting of the imaging. We create the paths of the data files including the  $B_1$  field map a mask file (which in this cases describes the whole data cube, only):

The acquisition parameters (echo time ( $TE$ ) in milliseconds, repetition time ( $TR$ ) in milliseconds and flip angle ( $FA$ ) in degree) for each volume are replicated from the original MPM data:

The package **pkg** provides a function `readMPMData` to read the data into an R session

which creates an object `mpm` of class "MPMdata".

## 2 Parameter estimation (ESTATICS)

The ESTATICS model (Weiskopf et al. 2014) describes the data from an MPM sequence by the relaxation rate  $R_2^*$  for the signal decay with the echo time  $TE$  and the three absolute values for  $TE = 0$ . Parameters in this model can be estimated by

```

> setCores(2)
> modelMPM <- estimateESTATICS(mpm,

using nonlinear least-squares regression. However, the low low signal-to-noise ratio (SNR) in the data leads to a bias for the parameter estimates, see Polzehl and Tabelow 2016 and Tabelow et al. 2017. Therefore the parameter estimation can alternatively be performed by

```

> sigma <- array(50, mpm$sdim)

using a quasi-likelihood formulation (Polzehl and Tabelow 2016; Tabelow et al. 2017). It avoids, in case of low SNR, the bias caused by the skewness of the Rician signal distribution. The application of this method requires to specify the scale parameter  $\sigma$  of the Rician distribution, which in this case of artificial data is explicitly known. Alternatively, a map of scale parameters could be estimated using function `awslsigmc` from package `dti`

```
> ddata <- extract(mpmp, "ddata")
> mask <- extract(mpmp, "mask")
> if(require(dt)) sigma <- awslsigmc(ddata[,,], 16, mask)$sigma
```

see Tabelow, Voss, and Polzehl 2015 for details of the method.


### 3 Structural adaptive smoothing

Data from MPM sequences suffer from noise hindering the quality of the estimated quantitative maps. Mohammadi et al. 2017 introduced a structural adaptive smoothing method that can be used to reduce the variability of the estimated parameter maps and, if `mpmData` is specified, the observed image data:

The package `qMRI` implements an extension of the method that uses the comparison of local patches for adaptive smoothing (Polzehl, Papafitsoros, and Tabelow 2018). The resulting ESTATICS unsmoothed and smoothed parameter maps for the central coronal slice can be illustrated by

The preceding code also applies the adaptive smoothing not only to the parameter maps of the ESTATICS model, but also to the data itself. From this new parameter maps can be estimated by the quasi-likelihood formulation and thus avoiding the bias due to the skewness in the signal distribution:

Note, that we again employ the same Rician scale parameter, i.e., of the unprocessed data, cf. the discussion in Polzehl and Tabelow 2016.

## 4 Calculating quantitative maps

Finally, from the (un)smoothed parameter maps of the ESTATICS model, we can compute the quantitative  $R_1$ ,  $R_2^*$ ,  $PD$  and  $MT$  maps

The calculation requires the  $B_1$ -bias field, if available, and the  $TR_2$  parameter of the MTw sequence (Tabelow et al. 2019).

We show the central coronal slice of the estimated quantitative maps together with the maps for the ground truth used to generate the data



The color scheme `colMT` is designed to emphasize the grey matter (magenta) / white matter (yellow) contrast in the MT image with a `zlim = c(0,2)`.

Using the quasi-likelihood estimation method is, for low SNR, supposed to reduce the bias caused by the skewness of the Rician distribution, cf. Polzehl

and Tabelow 2016 and Tabelow et al. 2017.

Let's see which estimate performs best with respect to the root mean squared error (RMSE):

For interpretation we need to compare this to the mean parameter values

We see here, that using the quasi-likelihood estimation is supposed to reduce the bias of the estimated ESTATICS parameters, but does so at the cost of a slightly increased variance. Structural adaptive smoothing leads to a considerable reduction in RMSE. Modelling of the spatially smoothed data has the additional effect of reduced bias originating from data variability.
